A. CALL TO ORDER

The January 6, 2003, meeting of the DeSoto County Board of Supervisors was called to order by Supervisor Jessie Medlin, Board President 2002.

Chief Deputy Charlie Brown of the DeSoto County Sheriff's Department was present and did open the DeSoto County Board of Supervisors meeting in a regular session to hear any and all business to come before the Board. The following were present:

B. INVOCATION

Board Attorney Bobby Chamberlin presented the invocation.

C. PLEDGE OF ALLEGIANCE

D. APPROVAL OF DECEMBER MINUTES

The official minutes of the Board of Supervisors were read for the month of December 2002, pursuant to Section 19-3-27 of the Mississippi Code of 1972, Annotated. Supervisor John Caldwell made the motion and Supervisor Tommy Lewis seconded the motion to approve the minutes of the Board of Supervisors, with clarifications made by the Supervisors, for the month of December 2002. The motion passed by a unanimous vote.

E. ORGANIZATION OF THE BOARD OF SUPERVISORS

In accordance with Section 19-3-7 of the Mississippi Code of 1972, the members of the Board of Supervisors shall meet on the first Monday in January and shall organize by electing one of their number to be President, and by electing one of their number to be Vice President, and being so organized, and attended by the Sheriff and Clerk, the board may proceed to discharge its duties.

1. Board President

Supervisor Jessie Medlin, Board President for 2002, opened the floor for nominations

for President. Supervisor Eugene Thach nominated Supervisor John Caldwell for President of the Board. Supervisor Tommy Lewis nominated Supervisor Gerald Clifton for President of the Board. With no other nominations, Supervisor Jessie Medlin closed the floor for nominations. Supervisor Jessie Medlin made a motion and Gerald Clifton seconded the motion for Supervisor Gerald Clifton to be President of the Board. Supervisor Gerald Clifton was elected as President by a vote as follows:

Supervisor Jessie Medlin passed the Board President seat to Supervisor Gerald Clifton. Supervisor Clifton commended Supervisor Medlin for a well done job as President in 2002 and gave a brief recap of the advances made by this Board of Supervisors for the last three years. Supervisor Clifton stated the construction of the new DHS Building, the Jail expansion, the Courthouse Renovation, the new District Attorney's Office, the expansion of the Hernando Library and the beginnings of the Waste Water System. All of this has been done without a tax increase to the County taxpayers. This Board has also completed several road construction projects and undertaken some new projects to help maintain traffic flow in congested parts of DeSoto County. The Board has been successful in helping to recruit new economic development in the County to increase employment.

2. Board Vice-President

Supervisor Gerald Clifton opened the floor for nominations for Vice President of the Board. Supervisor John Caldwell nominated Supervisor Tommy Lewis as Vice President of the Board. No other nominations were made. Supervisor Eugene Thach seconded this nomination. The nomination was approved by a unanimous vote.

F. OLD BUSINESS

1. Report from Committee to Inspect Road

a. Harper Road

Supervisor Tommy Lewis said that he had looked at this road twice and saw no problem with the road. Supervisor Gerald Clifton said he also had looked at the road twice and saw no problems with adding this section of Harper Road to the County Road map and road register. Road Manager Russell Dorris provided affidavits showing County maintenance to Harper Road and Harper Cove located in Section 16, Township 3 South, Range 9 West, of DeSoto County and had explained this road was inadvertently omitted from the Count road map and register.

The Mississippi Code Annotated, Section 65-7-4, requires that on or before July 1, 2000, the Board of Supervisors of each County shall prepare and adopt an official map designating, delineating all public roads on the County road system. Changes to the County road system shall be recorded on this map as soon as is reasonably possible. All subsequent proceedings and changes to the County road system shall be recorded in the County road system register as soon as is reasonably possible. The Board of Supervisors recognizes that the failure to list an existing public road on the statutory road registry does not, in and of itself, amount to abandonment of a public road,

and with regard to a

public road that has not been abandoned but has be inadvertently omitted from the official map and register, the County should add the road to the map and register before the County works the road. Supervisor Tommy Lewis made the motion and Supervisor Gerald Clifton seconded the motion to add Harper Road and Harper Cove to the County road register and to make the signed affidavits concerning the road a part of the Board minutes. The motion passed by a unanimous vote. **See Exhibit F.1.a**

b. Horn Lake Road

Supervisor Tommy Lewis made the motion and Supervisor Gerald Clifton seconded the motion to carry this item over until the January 21, 2003 Board meeting. The motion passed by a unanimous vote.

G. NEW BUISINESS

1. Approval of Travel

Supervisor Eugene Thach said the Board had approved his travel to Washington DC for the I-69 Conference but the cost estimate of trip was not stated, which according to the AG Opinion needs to be stated. Supervisor Thach said the cost of airfare would be approximately \$650 plus the normal personal allowances per day for food, lodging and other travel expenses.

In accordance with Section 25-3-41 Mississippi Code of 1972, as amended, any official or employee of DeSoto County, Mississippi is hereby authorized to travel during the period of January 6, 2003 to February 3, 2003, as necessary, and incur travel expenses in the performance of their official duties for DeSoto County; that all such travel is hereby authorized, contingent on funds being available in the departmental budget of the individual traveling.

Supervisor John Caldwell made the motion and Supervisor Tommy Lewis seconded the motion to authorize DeSoto County employees or officials to travel during the period of January 6, 2003 to February 3, 2003, as necessary, and incur travel expenses in the performance of their official duties for DeSoto County and the travel cost for Supervisor Thach to travel to Washington DC for the I-69 Conference, with the cost of airfare being approximately \$650 plus the normal personal allowances per day for food and lodging. The motion passed by a unanimous vote.

2. Approval of Publication of Board Proceedings

Supervisor John Caldwell made the motion and Supervisor Tommy Lewis seconded the motion to approve the publication of Board Proceedings in accordance with Section 19-3-33 of the Mississippi Code, which states that the Board of Supervisors may have its proceedings published in some newspaper published in the county, and cause the same to be paid for out of the county treasury. The motion passed by a unanimous vote.

3. Approval of Bailiff Pay

Pursuant to Section 25-7-27, Section 1, paragraph (e), which allows for Constables working as Bailiffs to be paid as provided under Section 25-3-69, Mississippi Code of 1973, Annotated, Supervisor John Caldwell made the motion and Supervisor Tommy Lewis seconded the motion to pay Joe Holmes the amount of \$160.00 for the month of December 2002; to pay Lee Hodge the amount of \$200.00 for the month of December 2002; and to pay Floyd Medlin the amount of \$200.00 for the

December 2002, for their services as Bailiffs for DeSoto County Justice Court. The motion passed by a unanimous vote. **See Exhibit G.3**

4. Approval of Justice Court Report

Justice Court Clerk Linda Aldridge appeared before the Board of Supervisors to present the Justice Court Report for the month of December 2002. Supervisor Eugene Thach made the motion and Supervisor Jessie Medlin seconded the motion to approve the Justice Court Report for the month of December 2002 attached as Exhibit G.4. The motion passed by a unanimous vote. **See Exhibit G.4****

5. Sheriff's Employee Report

Supervisor Tommy Lewis made the motion and Supervisor Eugene Thach seconded the motion to acknowledge receipt of the Sheriff's Department Employee Report for the month of December 2002. The report is attached and made a part of the minutes in Exhibit G.5. The motion passed by a unanimous vote. **See Exhibit G.5**

6. Sheriff's Department – Approval of Agreement for Government Acquisition Vehicle Procurement Program

County Administrator David Armstrong said this Government Acquisition Procurement Program is designed to enable the County Law Enforcement to provide a vehicle for use to assure the safety and welfare of the County through its "One Car, One Officer" program while avoiding the expenditures and budgetary concerns associated with the purchase of such Law Enforcement Vehicles for the County. David Armstrong said the program requires a Sponsor Logo being placed on the cars. David Armstrong said the Sheriff's Department would like to get between 3 to 5 cars through this program.

Supervisor Jessie Medlin asked who would decide who the sponsor would be. Supervisor John Caldwell asked how much are the sponsorships. Supervisor Tommy Lewis asked if the County has the right to reject a sponsor. Board Attorney Bobby Chamberlin said he had spoken with Chief Charlie Brown regarding this contract and it prohibits themes of an alcohol, firearms, gaming or tobacco corporation or product.

Supervisor Eugene Thach asked how big would the logo be on the cars. Commander Frank Herring, of the Sheriff's Department, said the County would decide the size of the logo and that the car would be leased to the County for \$1.00.

Chancery Clerk Sluggo Davis said the State Audit Department would require the County logo to be in the proper place. Supervisor Thach said that the Board needed to see if this is legal to do this. Commander Herring said the County has been approved for 5 cars and that there would be one sponsor per vehicle.

Supervisor Jessie Medlin said the vehicles would be good for use in the neighborhood watch programs. Supervisor Gerald Clifton asked the Sheriff about the use of the cars by the schools.

Sheriff James Riley said the cars could not be parked at the jail and it was his intention to use the cars for the neighborhood watch programs. Sheriff Riley said he did not intend to embarrass the County or this Board, and this would save the taxpayers about \$60,000 to use this program.

Supervisor Tommy Lewis made the motion and Supervisor Jessie Medlin seconded

the motion to carry this item over until Wednesday, January 8, 2003, for the **ITEM G.6, CONTINUED,**

clarification on the limits of the sponsorships. The motion passed by a unanimous vote. **See Exhibit G.6**

7. Approval to Transfer Vehicle from Sheriff's Department to the City of Hernando and Remove from County Inventory

County Administrator David Armstrong said the Sheriff's Department has a wrecked vehicle at Central Maintenance that they want to donate it to the City of Hernando so they can use the spare parts.

At the recommendation of Supervisor Jessie Medlin, and in accordance with Section 31-7-13 of the Mississippi Code, which states that purchases, sales, transfers or trades are to be made by a private treaty agreement or through means of negotiation, from any federal agency or authority, another governing authority or state agency of the State of Mississippi, or any state agency of another state; it is the intent of this section to allow governmental entities to dispose of and/or purchase commodities from other governmental entities at a price that is agreed to by both parties, and this shall allow for purchases and/or sales at prices which may be determined to be below market value, which is in the best interest of the taxpayers of the State, and after determining that such a transfer is in the best interest of the residents of DeSoto County. Supervisor Jessie Medlin made a motion and Supervisor Eugene Thach seconded the motion to declare the vehicle as surplus and to remove it from inventory and insurance, and to transfer the vehicle from the Sheriff's Department to the City of Hernando Police Department at no charge for the following vehicle:

8. Approval to Open Bids for Library – Telephone & Video System

Supervisor Eugene Thach made the motion and Supervisor John Caldwell seconded the motion to authorize the County Administrator or his designee to open Bid File No. 03-501-001a for Telephone System and Bid File No. 03-501-001b for Video Surveillance System for the Hernando First Regional Library on January 8, 2003, at 10:00 a.m. The motion passed by a unanimous vote. **See Exhibit G.8**

9. Approval of Bid for Jail Laundry & Dormitory

Randy Scott, Superintendent for Kline Swinney, Jim Bearden, Director of Operations and Maintenance, and Kenny Evans, Director of Building and Grounds, appeared before the Board of Supervisors regarding the recent bid for the Jail Laundry & Dormitory. Mr. Scott said the low bid was from Wagner General Corp. for \$490,000 for the laundry and new dormitory facility at the jail. Mr. Scott said that the original cost estimate of \$385,000 did not have the \$50,000 contingency figured in. Mr. Scott said that he, Jim Bearden and Kenny Evans had met with the Wagner official to see how they could reduce the cost from \$490,000. Mr. Scott said they had been able to reduce the cost down to \$457,893.51 and this includes alternate #1 for the new fire alarm panel. The following is the cost reduction summary:

David Armstrong said that the sprinkler system in the trustee section of the jail needs to be addressed, since the Fire Marshall has given the County leeway on this due to the construction taking place. Mr. Scott, said the Fire Marshall has granted a temporary stay on the trustee and womens area. Supervisor Jessie Medlin asked if the sprinkler would be installed in the laundry and dormitory area. Mr. Scott said the problem with the trustee area is that it is the original wooden jail and there are two construction types connecting the old jail and the new jail. We can't install the sprinkler system because of this. Board Attorney Bobby Chamberlin asked what it would take to bring the trustee area into conformity. Mr. Scott said that a firewall would have to be installed between the two building types and this would be very costly to do and would reduce space. Mr. Scott recommended tearing down the old jail and constructing a new facility. This area is now the juvenile section of the jail. Mr. Scott said the County needs to determine what the future plans are.

Sheriff Riley said they were looking at the next 10 years on the jail and to do the work in two phases. Phase one was to build a two story building and then Phase two is to tear out the old wooden jail and build in this area. Sheriff Riley said he has 288 inmates in the jail at this time and the State has plans to take 22 State inmates by Friday, and this will leave 54 beds empty.

Supervisor Eugene Thach asked if the dormitory area was considered to be a temporary arrangement. Mr. Scott said the dormitory was being built to code and could be a permanent area according to the plans.

Supervisor Tommy Lewis made the motion to take this information under advisement until Wednesday, January 8, 2003. Supervisor John Caldwell seconded the motion.

After further discussion Supervisor Lewis and Supervisor Caldwell withdrew their motion and second.

Jim Bearden said that if the Board approved the bid by Wagner, the contract could start immediately. Jim Bearden said the jail is under immediate need of the laundry facility. Supervisor Caldwell said the Board owed the contractor to make a decision on this item before the contractors spend money for bond requirements.

Kenny Evans said even though the trustee area does not have the sprinkler system, there has been a lot of fire protection added for the facility.

Sheriff Riley said he recommended proceeding with this construction. Supervisor Caldwell said they would have to increase the recreation area during the next construction.

David Armstrong said the construction would take 6 months with a \$1,000 a day

contingency.

Supervisor Jessie Medlin made the motion and Supervisor Eugene Thach seconded the motion to accept the low bid from Wagner General Corp. for the construction of the laundry and dormitory facilities at the jail, based on the recommendation of the Sheriff to proceed with this construction, and authorize the Board President to sign the contract. The motion passed by a unanimous vote. **See Exhibit G.9**

10. Renewal of Jail Physician Contract

County Administrator David Armstrong said the two year contract for the Jail Physician, Rob Meacham, is due for renewal. The 2001 contract salary was \$85,168.13 with a 3% increase for 2002, which makes the salary \$87,723.17 at this time. David Armstrong said when he asked Dr. Meacham what amount he was looking for, he said \$120,000 and he advised him that he could not recommend this amount to the Board.

Sheriff Riley said he had spoken with Dr. Meacham and he had agreed to take a 5% increase in salary for 2003, but wanted a 10% increase for the second year. Sheriff Riley said that Dr. Meacham is on call 24 hours a day at the jail and they call him out all thru the night. This has saved the County money by having this service. We have doubled the facility during this time and he has to see more inmates.

Supervisor John Caldwell made the motion and Supervisor Eugene Thach seconded the motion to approve a 5% increase in salary for the next two years, with the 2003 salary being \$92,109.33 and the 2004 salary being \$96,714.79 and authorize the Board President to sign the contract. The motion passed by a vote as follows:

Supervisor Jessie Medlin said he hates to see Dr. Meacham accept the contract if he is not happy. The County could go out for proposals, from someone else. **See Exhibit G.10**

11. Civil Defense – Local Emergency Management Program Enhancement Grant

T. H. Walker, Director of Emergency Management, appeared before the Board of Supervisors to discuss the recent grant received for the Local Emergency Management Program Enhancement. Mr. Walker said this grant is for \$16,500 to allow the purchase the following equipment:

Mr. Walker said he is designated as the grant administrator, but the Board President must sign the grant also. Mr. Walker said the County has to spend the money for the equipment and then be reimbursed by the grant and this has to be done by June 2003. Mr. Walker said a budget amendment would be required for the purchase of the

equipment.

Supervisor Tommy Lewis made the motion and Supervisor John Caldwell seconded the motion to authorize T. H. Walker to sign the Local Emergency Management Program Enhancement Grant, and to authorize a budget amendment necessary for the purchase of the equipment to be reimbursed by the grant. The motion passed by a unanimous vote. ** See Exhibit G.11**

12. Comptroller – Joyce Riales

a. Interfund Loan

Comptroller Joyce Riales said an interfund loan is needed to cover claims on the January 6, 2003 docket. This loan will be repaid when sufficient funds are received from the State Development Bank, EPA, or the State Library Capital Improvement Grant Funds.

Supervisor Jessie Medlin made the motion and Supervisor Tommy Lewis seconded the motion to approve the following interfund loan, based upon the recommendation of the Comptroller Joyce Riales:

d. Claims Docket

Comptroller Joyce Riales and Stephanie Hanks, Accounting Clerk, presented the claims docket showing claims to be paid for various departments as of January 6, 2003, in the amount of \$2,125,369.29.

Supervisor John Caldwell said the County is paying Bill Austin a consulting fee for the DCRUA and he asked the Board Attorney to see if the use of a County office by a consultant had the same rules as an office supplied for a contractor.

Supervisor Jessie Medlin asked Stephanie Hanks to check with Jim Bearden about the bill on the Fairview Ballfield dumpster and asked that payment be held until this could be done.

Supervisor John Caldwell made the motion and Supervisor Eugene Thach seconded the motion to approve the payment of the claims docket in the amount of \$2,125,369.29 and authorized the clerk to write the checks except the check for the ball park. The motion passed by a vote as follows:

Supervisor Medlin said then to go ahead and pay the total claims docket. Supervisor Jessie Medlin made the motion and Supervisor Eugene Thach seconded the motion to pay the bill for the ballpark. The motion passed by a unanimous vote.

Pursuant to Section 65-17-7 of the Mississippi Code of 1972, Annotated, Road Manager Russell Dorris presented the Road Report for November 26, 2002 to December 25, 2002 and the Work Schedule for the month of January 2003 and the

15. Justice Court – Approval to Adjust Cingular Contract

Vanessa Lynchard, Director of Administrative Services, addressed the Board of Supervisors regarding approval to adjust the Cingular Contract for Justice Court to add option mobile to mobile to their phones. Ms. Lynchard said the Judges talk a lot with different Judges about cases and this would cut down on their bills.

Supervisor Eugene Thach asked Vanessa Lynchard to look at his Cingular contract to see if the mobile to mobile should be added. Supervisor Thach said that Central Maintenance should have this feature added to all of their phones as well. Ms. Lynchard said that Central Maintenance already has this feature.

Supervisor Tommy Lewis made the motion and Supervisor Eugene Thach seconded the motion to authorize adding the option of mobile to mobile to the Cingular contracts to any Board of Supervisors, County Administrator, Justice Court and Central Maintenance phones that does not have it. Board Attorney Bobby Chamberlin said the City of Olive Branch has to pass a City Ordinance in order to collect the \$700 Wastewater Fee and this cannot take place until a public hearing is held. They hope to be able to have the ordinance in effect by February 1, 2003. Bobby Chamberlin said that all Cities should collect the wastewater fee, hopefully at the same time, and that these funds go toward the construction of the facility. Bobby Chamberlin said the County can't charge the fee, they can only regulate the fee for the DCRUA. Supervisor Jessie Medlin asked why the County couldn't start the collection, since the agreement said the County would collect the fee if the Cities collected the fee. Bobby Chamberlin said the Board of Supervisors regulated to set the date of collection to be January 1, 2003.

I. OTHER ISSUES

1. Mississippi Valley Gas Permit

Road Manager Russell Dorris said that Mississippi Valley Gas has made an application to place utility lines and they don't want to give a bond while the work is being done. Supervisor Gerald Clifton said he had talked with MVG and they have agreed to place the utility lines off the right of way.
