D. CITIZENS REMARKS & PRESENTATIONS – Proclamation to Proclaim the Month of October Domestic Violence Awareness Month

Supervisor Lee Caldwell read the proclamation as follows:

PROCLAMATION DOMESTIC VIOLENCE AWARENESS MONTH OCTOBER 2014

WHEREAS, domestic violence impacts countless DeSoto Countians, without regard to age, race, religion, or economic status; as victims suffer at the hands of a spouse or partner, it affects their children, families, and entire communities; and

WHEREAS, every woman, child, and man has the right to live free of violence at home and in neighborhoods, schools, communities across DeSoto County; and

WHEREAS, domestic violence violates a person's trust and feeling of safety. The rights and needs of domestic violence victims are a priority for DeSoto County and the nation as a whole; and

WHEREAS, there is compelling evidence that we can be successful in reducing domestic violence in DeSoto County through prevention education, increased awareness, and insuring justice for victims of violence by holding perpetrators responsible for their actions; and

WHEREAS, important partnerships have been formed among criminal and juvenile justice agencies, healthcare providers, allied professionals, and victim services to assist victims of domestic violence and their families. In DeSoto County the House of Grace provides a resource

for victims of domestic violence; and

WHEREAS, we encourage domestic violence victims and their families to seek assistance from appropriate victims' services organization.

NOW, THEREFORE, We, the DeSoto County Board of Supervisors, do hereby proclaim the month of October as:

DOMESTIC VIOLENCE AWARENESS MONTH

In DeSoto County, Mississippi and urge our citizens to work together to eliminate domestic violence from our community.

F. APPROVAL OF AGENDA: ADDITIONS AND DELETIONS

Supervisor Lee Caldwell asked if there was anyone who wished to add or delete items to the Agenda.

Vanessa Lynchard requested adding the following:

Old Business

1. Swinnea Road Update

Supervisor Mark Gardner met with the City of Southaven last week to discuss options for sidewalks. He said that option "C" meets all the standards for bike and pedestrian lanes due to cost. Supervisor Gardner said that property acquisition came in a little under estimate. He said that Neel Schaffer does want to pursue this option. Supervisor Gardner said that the City of Southaven planned too bid this out as originally designed but are now considering an alternate bid with the pedestrian and bike lane.

Supervisor Lee Caldwell said there may be MPO grant money to build the bike lanes. Supervisor Caldwell said she does not want to add anymore to the project that would require more easements. She said the Mayor is very interested in completing this.

No action was taken on this item.

Road Manager Andy Swims said that Soccer Field Road is open now and really looks good. Sheriff Bill Rasco agreed, and said they did a good job on the road.

2. Off-Street Parking

Supervisor Bill Russell said the County continues to have problems with people parking in "No Parking" areas right next to the "No Parking" sign. Supervisor Russell said the one he is referring to now, is at Poplar Corner and Goodman Road. He said Attorney Jody Neyman had recommended adoption of a new ordinance that would allow the Sheriff's Department to issue tickets. Supervisor Russell asked the Board if they were interested in forming a committee to draft a new ordinance that would address this issue. The proper ordinance would allow the Board of Supervisors and the Sheriff to have authority with these issues. If a person parks on public property and the vehicle has no tags, the Sheriff can tow the vehicle. If someone parks on private property now there is nothing the Board or Sheriff can do about it.

Supervisor Bill Russell made the motion and Supervisor Lee Caldwell seconded the motion to approve a committee to review option to control illegal parking on private property; and to appoint Supervisor Bill Russell and Sheriff Bill Rasco.

5. Cable Regulations

Supervisor Mark Gardner expressed concerns about the residents of DeSoto County continuously receiving poor customer service from Comcast. Supervisor Gardner said the Board met with omcast representatives and he has not seen improvement in customer service. He said the residents in Edgewater have experienced outages for several days and has still not been repaired, and the customer service is incredibly poor. Supervisor Gardner said the Board received Comcast Franchise Agreement for DeSoto County last week and he will not vote on it until they improve their service.

6. USDA Lease Agreement

Supervisor Mark Gardner said that the space for NRCS was not completed and the USDA got a one year extension and it is has expired.

7. Bond Refinance

DeSoto County Financial Advisor Demery Grubbs said they are continuously looking at the county bond for opportunities to refund existing bonds in order to improve the County's financial position. Mr. Grubbs said they are currently reviewing the 2007 and 2009 bonds. He said they could reissue the 2007 and 2009 bonds with advanced refunding at 2.10% refinancing. That would mean a savings to the County of \$441,000. Mr. Grubbs said we could replace the higher interest rate with lower interest rate and the maturity date would remain the same, 2024.

Supervisor Bill Russell made the motion and Supervisor Jessie Medlin seconded the motion to approve allowing the DeSoto County Financial Consultant to proceed with the Piper Jaffrey and Smith Phillips Law Firm to work on bond refinancing for the 2007 and 2009 bonds and to bring the documents back to the Board of Supervisors.

Mr. Grubbs said he received numbers from DCRUA about refinancing. Mr. Grubbs said they could do a revenue bond but it must be issued through the County. He said if DCRUA wants to proceed, they would pledge their revenues and not the County's, but it has to be issued through the County. It is DCRUA's debt and could save about one half million dollars.

Supervisor Harvey Lee made the motion and Supervisor Mark Gardner seconded the motion to approve authorizing the DeSoto County Financial Advisor to precede working with Duncan Williams about refinancing of a revenue bond for DCRUA and bring the documents back to the Board of Supervisors.

9. Corp of Engineer Update

Supervisor Mark Gardner said there was a very positive meeting with the Corp of Engineering regarding a comprehensive study of flooding in the County. Supervisor Gardner said now there is money available and we just need someone to lead the process. He said that COG thought that the County should take the lead.

Supervisor Jessie Medlin asked if there were matching funds required. Supervisor Lee Caldwell said that 20% match is required but can be in-kind. She said the implementation could be done while the study is being done. Supervisor Medlin said we need to look at all avenues and federal money that is available. Supervisor Bill Russell said the drainage districts need to be active again.

No action was taken on this item.

- 10. Spring Lake Blvd ROW This item was later determined to qualify for executive session.
- 11. Chief Financial Officer Tom Arnold said there is a Road Department pickup truck in the body shop; the body shop will not release it until the County pays the \$2,000 deductible. He requested approval to file an insurance claim to get the truck out of the body shop.

- 12. Road Manager Andy Swims requested adding two items for possible executive session discussion under personnel. These items were later determined to qualify for executive session.
- 13. Mr. Swims also requested an item of new business: Finding of Fact Spring Lakes Blvd.- College Hills Subdivision

Mr. Swims said there were damages to private property associated with drainage and erosion in College Hills Subdivision. He said it would be necessary to clean the swell and place rip rap between residences to allow the cross drain pipe to drain properly at an estimated cost of \$2,678.74.

Supervisor Mark Gardner made the motion and Supervisor Harvey Lee seconded the motion to accept the finding of fact and that the conditions between 3580 and 3550 Spring Lakes Blvd. in College Hills Subdivision would adversely affect the health, safety and welfare of the citizens of DeSoto County in accordance with Mississippi code section 19-5-92.1, that it would be necessary to clean the swell and place riprap between 3580 and 3550 Spring Lakes Blvd, College Hills Subdivision to allow the cross drain pipe to drain properly as this will help prevent future flooding and protect the road and right of way, and to authorize the Road Manager to proceed with the work at an estimated cost of \$2,378.74.

2. Wedgewood Bank & Stabilization Funding

Assistant Engineer Scott Young proposed expanding this project along Nolehole Creek in order to shore up the ditch. Mr. Young said the estimate for the project would be at least \$150,000 with \$40,000 coming from each entity.

Supervisor Mark Gardner said there is a real problem in this subdivision and he met with NRCS and the residents two years ago. Supervisor Gardner said NRCS approved \$40,000 which is a small Band-Aid on a larger problem. He said he would like the project to be expanded. Mr. Swims said the Road Department does have money for work on the ditch. He said the money could partially be spent on right of way and private property. We can spend \$11,000 from NRCS money.

Supervisor Gardner said we must know we will have the 25% local match.

Supervisor Jessie Medlin asked if there was anything the City of Olive Branch was doing to prevent the flooding caused by the new subdivision.

The Board discussed the new construction in the area and how some of it is being handled. Supervisor Medlin said at some point they are going to need a detention pond because there is a lot of construction going on in that area.

Mr. Young clarified that the County's portion is \$40,000 and that 10% of that amount could be in-kind work.

The tax collector shall also include in his report any checks, drafts or orders for the payment of money which he has received in payment of ad valorem taxes and which has been returned to him because of insufficient funds in the account on which such checks, drafts or orders were drawn. Such checks, drafts or orders shall be accompanied by the affidavit of the collector that he has exhausted all legal means of collecting such instruments, including the filing of a civil suit.

3. Natural Resources Conservation Service Available Funding

Road Manager Andy Swims said, as a result of the rain event on September 11, 2014, Assistant County Engineer, Scott Young met with NRCS regarding erosion and scour issues.

Mr. Young said he met with NRCS for six hours. He said they agreed upon three projects with a 75/25 funding split and allowing 10% of the work to be done in-kind like they do on other projects. The first project is for College Road, \$96,000 – major ditch crossing between Getwell Rd. & Pleasant Hill Rd.

Mr. Young said they also identified a project along Spring Valley Road. The project will use rip rap and replace a pipe on Spring Valley Road at an estimated cost of \$57,000.

Finally, Mr. Young stated they identified a project for the Tulane Road Bridge at I69. The bridge is in the City of Hernando and he will contact them to join in on this project. The project is to repair scouring and washing of the banks under the bridge. Mr. Young said the estimated cost is \$80,500.

Mr. Young said the County share on these projects is \$58,375.

Mr. Young said that College Road and Spring Valley still meet all NRCS designs. Spring Valley is critical because there is only one entrance to that subdivision. He said they could prioritize College Road and Spring Valley and submit the applications.

b. NACo Prescription Update & Introduction of the Health Care Discount Program

Director of Administrative Services Pat McLeod said the BOS participated in the NACo Prescription Program in 2009. b. Fairhaven Fire Department: Approval to Bid

c. Approval of agreement with Fairhaven VFD

County Administrator Vanessa Lynchard said the cost of renovating the building used by the Fairhaven Fire Department exceeds what they originally thought it would cost. She said the Fire Department is comfortable with paying rent to use the building, in exchange for the improvements. Ms. Lynchard said Architect Marvin Johnson is working on this project.

Board Attorney Tony Nowak said this is not a loan, but a lease agreement between the County and Fairhaven Fire Department. Ms. Lynchard said they could pay up to \$14,000 yearly. The County owns the building and will retain ownership.

Mr. Johnson discussed the project plan and said the building would have metal siding and roofing and will look like the original concept of the building. Mr. Johnson said there is no need for dirt work around the building except for the parking pad.

Mr. Johnson said the sleeping quarters are in the back of the building. The addition will be elevated but the parking lot will be the same level as it is now.

Supervisor Medlin asked if the parking lot flooded during the last storm. EMA Operations Specialist Josh Harper said there was no water over the parking lot during the last rains and flooding in the county.

Supervisor Mark Gardner asked if the building is ADA compliant. Mr. Johnson said yes. He said they do have to install a sprinkler according to Fire Code because there will be a sleeping quarters. Mr. Johnson said it is a residential sprinkler because of the size of the building. Mr. Johnson said it will be cheaper than the one at Eudora because the building is not as big at Fairhaven. There is a water hydrant in front of the Fairhaven building. Mr. Johnson said the total for the entire project is \$300,000 to \$325,000.

Mr. Garrod stated with all the cities adopting the 2012 Building Code, by adopting the code all jurisdictions will be using the same code. Supervisor Gardner asked if the Supervisors can get a summary of all the changes to be able to answer any questions that citizens may have. Supervisor Medlin stated he would like to see what the changes in the building code will cost the homebuyer and the builder.

Supervisor Russell stated he would like to discuss selling of cars on public right-of-way. He then stated that the intersection of Poplar Corner and Goodman Road looks like a used car lot. He asked if anything could be done to allow the Sherriff's Department to ticket these vehicles. Mr. Garrod stated he spoke with Mr. Nowak and that the County would need a specific ordinance to be able to ticket the vehicles.

Supervisor Russell asked if the Board was interested in forming a committee to look into an ordinance to address this situation.

Supervisor Lee asked if that area was MDOT right-of-way. Supervisor Russell stated he would have to look into that.
