B. INVOCATION

Chancery Clerk Sluggo Davis presented the invocation.

E. NEW BUSINESS

1. Budget Amendments

Chief Financial Officer Tom Arnold presented budget amendments for the Board's consideration for approval.

Supervisor Mark Gardner made the motion and Supervisor Jessie Medlin seconded the motion to approve the budget amendments as detailed in Exhibit E.1.

2. Firearms in Public Buildings

Board Attorney, Jody Neyman, appeared to discuss the status of the open carry statute. Mr. Neyman said the Board order regulating the carrying of firearms in County buildings, which was approved September, 2013, has been found by the Attorney General's office to be in non-compliance with the current law and should be revoked immediately. The order that was previously approved prohibits people from the open carrying or possession of weapons in county buildings, and prohibits the concealed carrying without an enhanced concealed permit. The Attorney General's Office said that the Board order does not comply with the recent amendments to the law that were passed earlier this year. Mr. Neyman reviewed the law regarding the carrying of weapons and what the Board of Supervisors can and cannot regulate. Mr. Neyman advised the Board that Judges can still prohibit weapons from inside their courtroom, at their discretion, pursuant to Section 45-9-53.

Mr. Neyman said neither a municipality nor county has the statutory authority to regulate by ordinance the carrying of any weapon, concealed or open, except in places specifically specified in Section 45-9-53. He said that schools may also prohibit firearms in or on their premises according to law.

Supervisor Mark Gardner made the motion and Supervisor Jessie Medlin seconded the motion to rescind the previous Board order from September 2013, regulating the carrying of firearms in public buildings and to remove all signs restricting the carrying of firearms that have been posted per the directives of the Board order.

Mr. Neyman then advised the Board that the Sheriff still retains the authority to oversee security at the Courthouse and may post updated signs which comply with the current law. Mr. Neyman will visit with the Sheriff to be sure proper signs are posted.

3. Comcast Franchise Agreement Renewal Update

Supervisor Mark Gardner said that there is not a lot of news about improvements with Comcast's service. Supervisor Gardner said Comcast added three techs for DeSoto County. He said they still have a lot of improvement to do.

Board Attorney Tony Nowak said draft the franchise agreement is lengthy and needs to be revised. He met with Otha Brandon and discussed a number of revisions that should be incorporated into the franchise agreement.

Supervisor Jessie Medlin asked if there is a local person that we can contact. Supervisor Gardner said no. He said that Comcast brings business to DeSoto County. He said he gets more complaints about Comcast's service than roads in the county.

Mr. Nowak said Comcast is currently working under the auto renewal provisions of the Cable Communications Act. He said the Board has already approved him to work on the franchise agreement.

Supervisor Jessie Medlin said the more the Board is involved with Comcast issues, the more it appears to the public that we have control over Comcast and we have no control over them at all. He said he would like to be able to at least reach someone who speaks English when people call Comcast.

No motions were made nor votes taken on this issue.

4. Budget Discussions FY15

County Administrator Vanessa Lynchard thanked Comptroller Tom Arnold and his staff, department heads, managers and the Board of Supervisors for their participation in the proposed budget. Almost every department had no increase in their proposed budgets as they dealt with essentials and non-essentials. Ms. Lynchard said there were some items that were on departmental lists for two years and they still pushed it back. Ms. Lynchard said she could not say enough about the employees of this county.

Ms. Lynchard made the following comments:

The Board of Supervisors' strong leadership and vision have kept the taxpayers of the county from likely bearing a tax increase in FY15 if services were to remain at the current high level. <u>Assessed values plus in lieu taxes</u> have remained basically the same since 2009. The cost of doing business has grows every year as our population increases and federal and state mandates increase.


This Board and past Boards have followed through their commitment to strong, fiscally conservative leadership. This budget closes ten years without a millage increase. Your employees and county elected officials have again contributed to making this amazing history a reality, by cutting and/or controlling their spending and committing to doing that again in FY15. Yet there are rising costs to consider

Thanks to your strong "team approach" to county government management and strong fiscal control, the county is poised to meet the challenges of FY15.

There are some decisions to be made by the Board to convert this budget draft to a final document. Once again, the Board's wisdom and love for this county will lead to the adoption of the FY15 budget.



Supervisor Mark Gardner said that employees got a 3% increase over the last few years.

Ms. Lynchard presented a chart reflecting information about General Fund Expenses 6 year History,



FY08-FY13.

The Board also discussed assessed values being down and how fee in lieu of taxes impacts the assessed

Supervisor Jessie Medlin said the Board needs to be cautious when approving companies for fee in lieu.

Supervisor Gardner said the employees have received a 3% increase the last few years. Ms. Lynchard said that the total expense for salaries and fringes for 2013 is \$31,986,883. Supervisor Gardner said there was a year or two that the employees did not receive raises. Supervisor Medlin said the Board gave the employees nice raises when the county was booming with growth.

The Board discussed the general fund and debt service. Supervisor Gardner asked if there are opportunities to refund or payoff bonds. Mr. Arnold said there may be a little bit on some but he thought that most of them were small. Supervisor Gardner said he would like to see if there are bonds so that we could pay off early. Supervisor Lee Caldwell said she spoke to County Financial Advisor Demery Grubbs and he did not think there was anything the Board could do either. Mr. Arnold said DeSoto County has one the highest credit ratings in the state. The Board has done a good job managing the taxpayer's money.

Sergeant Macon Moore of the Sheriff's Department introduced several officers who presented information on the rise in crime in DeSoto County. They all agreed there is a great need for more patrol vehicles and additional staff as the rate of crime rises in DeSoto County. A portion of the discussion is as follows:

- Includes three gang related drive-by shootings over zero the previous year to date.
- Increase partly attributed to new classification procedure.
- Other Crimes Assigned for investigation: Found property, civil matters, fire investigations, runaway juveniles, etc.
- January through June due to items still being processed for July 2014.
- Increase partly due to implementation of new database reporting procedures.
- Workload has required latent processing work to be sent to State Crime Lab.

Sheriff Bill Rasco presented estimates for additional vehicles and staffing.

Supervisor Lee Caldwell said the Board appreciates the Sheriff's Department's presentation. She said we agreed on cutting \$450,000. Ms. Lynchard said actually the agreement was to cut \$475,000 last year and \$475,000 this year. Supervisor Caldwell said they also agreed on two less deputies. She said the Board may have to ask for a millage increase because we do not have the money.

Sheriff Rasco said they just wanted to show the Board what their needs are and why.

Supervisor Gardner said they appreciate all the work the Sheriff's Department did on the presentation. It was presented very well and our number one concern is public safety. He said they will try to find out where they can get the additional funding needed for the Sheriff's Department.

The Board discussed the Sheriff's request and agreed to wait until the budget was completely covered to see how much money would be reduced that might be directed to the Sheriff's needs.

The Board of Supervisors discussed the BOS budget on page 12. Supervisor Bill Russell recommended line number 476 for meals and lodging be reduced to \$5,000. Supervisor Russell said we asked for a tight budget and the Board should be tight as well.

Supervisor Mark Gardner said that some of the meetings have been very beneficial. Supervisor Jessie Medlin said some of the meetings help but some don't.

Supervisor Bill Russell said he has had two senators say that we send too many people on the Blue Ribbon trip. He said they have made progress on the Blue Ribbon trips because all of the cities attend and participate in discussion relating to the county.

Supervisor Lee Caldwell said that air quality and transportation are important issues in the county.

Supervisor Russell said the Board can always make a decision to amend the budget if more travel funding is necessary.

Supervisor Jessie Medlin made the motion and Supervisor Harvey Lee seconded the motion to approve reducing line number 001-100-476 on page 12 of the BOS budget for meals and lodging to \$5,000. The motion passed by a vote as follows:
