#### D. CITIZENS REMARKS & PRESENTATIONS

Supervisor Lee Caldwell asked if there was anyone who wished to come forward who is not on the Agenda. No one came forward.

# E. APPROVAL OF AGENDA: ADDITIONS AND DELETIONS

Supervisor Lee Caldwell asked if there was anyone who wished to add or delete items to the Agenda.

- 1. County Administrator Vanessa Lynchard requested the following additions and deletions to the Agenda:

#### G. OLD BUSINESS

#### 1. Budget Discussions FY15

The Board of Supervisors discussed various line items in the budget from page 55 to page 92. They read each line item and discussed the impact of the reductions on the departments.

Supervisor Jessie Medlin made the motion and Supervisor Mark Gardner seconded the motion to reduce meals and lodging in EMA line item number 001-260-476 to \$1,000 from \$4,800. The motion passed by a vote as follows:

The Board agreed for Ms. Lynchard to work with EMA to clean up the transition issues and how it will affect the budget.

Ms. Lynchard said the new policy for overtime for the Animal Control Officers will affect the budget.

Supervisor Bill Russell recommended not changing anything on the budget for Region IV.

Supervisor Bill Russell made the motion and Supervisor Mark Gardner seconded the motion to change the allocation for the Planning Department for mileage and other travel cost back to \$1,100 in order to maintain necessary certifications.

#### H. NEW BUSINESS

#### 1. Office of Procurement

# a. Purchase exceeding \$25,000: Sheriff's Dept. - Mobile License Plate Reader

Sergeant Macon Moore and Procurement Clerk Karen McNeil presented two quotes to purchase a mobile license plate reader for the Sheriff's Department in an amount exceeding \$25,000.

Sgt. Moore said there is a signed agreement with Homeland Security and this is fully covered by a grant. He said this equipment will help with Amber Alerts and kidnappings and many other things. It reads the license plate number and searches the database and comes into their dispatch and they can put it out to other cities. It requires batteries and is maintenance free. The device can read the number on a license plate within two seconds.

Supervisor Jessie Medlin made the motion and Supervisor Mark Gardner seconded the motion to approve the purchase of a mobile license plate reader for the Sheriff's Department in the amount of \$39,000.00 with Homeland Security grant funds out of budget 110-202-918.

Supervisor Mark Gardner said this is a good use of technology and will help fight crime and there is no direct cost to taxpayer or the County budget. Supervisor Gardner said he did not see a down side.

Mr. Eric Boling of Eudora said he appreciated all that the deputies do. He said he is concerned about using more gadgets. He said he has had four vehicles stolen. Mr. Boling asked about software, installation, maintenance and upgrades for the equipment. He said he supports the county but feel like we need to rein in the gadget mania.

Supervisor Gardner said he hears Mr. Boling's concerns but he does not see a down side to this equipment.

Sgt. Moore said all software and servers are maintained in Jackson and he does not envision costs down the road. Sgt. Moore said he does not think any of the Sheriff's Departments buys gadgets just for the sake of buying them. He said this one is strictly used for finding suspects. If there is a tag that shows up on the hit list then we have a suspect. The tag number goes through Homeland Security which can search our camera and investigative data. The system is purged every 30 days.

Supervisor Lee Caldwell thanked Sgt. Moore and said they appreciate everything he does. Supervisor Caldwell told Mr. Boling that they appreciate his concerns but the Supervisors have to do what is best for the county.

Mr. Boling thanked the Supervisors for letting him speak to them about this matter.

# b. Bids under Advisement - Approval to Reject bids and Request to re-bid

# 1) Annual Traffic Striping

Ms. McNeil said two bids were received for traffic striping and only one of those bids included prices but that bid did not meet specifications.

Supervisor Jessie Medlin asked about how many vendors the bids specs were sent to. Ms. McNeil said about six vendors. She said they would like to rebid and use a 150 mile radius instead of 125 mile radius. She said they are not revealing the pricing of the one bid because they are requesting to rebid it.

Supervisor Gardner asked how much the Road Department spends on striping. Road Manager Andy Swims said striping is a good safety issue they try to stay on top of it as much as possible. Supervisor Gardner said he has received praise from a constituent about how well the county stripes the roads.

Supervisor Gardner asked if the county may need to buy a striping machine. Mr. Swims said they could look into that. He said they spent \$97,000 striping the roads through July. Mr. Swims said he would bring the cost of purchasing the vehicle, manpower and maintenance back to the Board.

Supervisor Mark Gardner made the motion and Supervisor Harvey Lee seconded the motion to approve rejecting and rebidding for the annual traffic striping for the County Road Department.

i. Crosswinds Rezoning (729) – Application is for approval of Rezoning of property from Agricultural-Residential (A-R) to Planned Unit Development (PUD), identified as Parcel #3-06-3-05-00-0-00015-01. Subject property is located on the east side of Craft Road and south of Byhalia Road in Section

# 5, Township 3, Range 6 and is zoned Agricultural-Residential (A-R). (District 5)

Mr. Haysley presented the Crosswinds Rezoning application and stated the Planning Commission had a tied vote on the recommendation of this item.

Supervisor Lee asked if there was anyone present to speak for this item.

Mr. Mike Bailey came forward and discussed the availability of gas and sewer for this project. He stated he spoke with the City of Olive Branch and they are working on the natural gas situation in the area. He then stated in the mean time until the issue is resolved they will start with all electric homes in the development if approved. He stated he is working on a sewer plan that MDEQ will approve. He presented a document concerning the sewer plan for the development. Supervisor Medlin stated the sewer lagoon will be east of the proposed site, will it be feasible to put the lagoon there with only 24 lots in the development. Mr. Bailey stated if put in that location that is where the pump station will be and when there is more development it will be able to hook into DCRUA. There was discussion of when it will be feasible to hook into DCRUA. Supervisor Gardner asked if neighbors have seen a copy of the letter concerning the sewer. Mr. Bailey stated he doesn't think the neighbors have seen the letter. Supervisor Medlin asked when hooking up to sanitary sewer would the point of hookup be at Craft Road or at the lagoon. Mr. Bailey stated whichever is more feasible would be where the hookup would be located. Supervisor Gardner pointed out in the letter where it stated once wastewater is treated at the house and leaves the house it is no longer hazardous. Supervisor Russell stated he has the same type of system in his neighborhood and MDEQ comes out every 18 months to test the water that is treated and sent to the community lake/creek and it is no longer hazardous. Supervisor Medlin asked who will manage this treatment system. Mr. Bailey stated he is not sure yet but that it will have to be someone who is licensed.

Mr. Pat Dorr came forward and stated he works for First Security Bank and has worked with this developer on other subdivision. He stated one particular subdivision he has worked with Mr. Bailey on is College Hills and it is a very nice subdivision with boulevards and a lagoon near or in the flood zone. He then stated Mr. Bailey is very capable and takes pride in his developments. He stated he is in support of the developer.

Supervisor Lee asked if there was anyone present to speak against this item.

Mr. Terry Abner came forward and stated he feels this development is uncharacteristic of the neighborhood. He stated he was told the Health Department would be diligent about enforcing the smell from the treatment plant, but that when he spoke with the Health Department they stated they only get involved if the system is malfunctioning. He stated he was told by Bradley Crane with the State that the systems would have to be overseen by the utility company.

Mr. Tim Curtis – 2382 Fletcher Cove- stated the homes are uncharacteristic of the neighborhood and the citizens of the community are all against the project. He then stated they have problems with drainage in his development, they have septic problems with the sewer systems and their subdivision was developed by Mike Bailey. He stated the septic systems are too small for the homes. He stated the members of the community beg the Board not to shove this type of development down their throats.

Supervisor Gardner asked how close Mr. Curtis's house is to the proposed development. Mr. Curtis stated his home is a about a mile from the proposed development. Supervisor Gardner asked what lot size would be acceptable to Mr. Curtis. Mr. Curtis stated ¾ acres would be acceptable. Supervisor Medlin asked what type of sewer system Mr. Curtis has in his development. Mr. Curtis stated he has the same type of system that is being proposed in the development.

Mr. Murray Hayslip came forward and stated the community is against this development because the lots are too small. He stated there are no ½ acre lots in the area. He stated he would go along with ¾ acre lots. Supervisor Medlin asked what size lots are approved in Mr. Hayslip's development. Mr. Hayslip stated his development was approved for 1 ½ acre lots. Supervisor Medlin asked what the lot sizes in Villages of Hawks Crossing are. Mr. Haysley stated the lots range in size from ¾ acres down to 12,000 sqf.

Ms. Rebecca Remington came forward and stated there is not a public need for this type of development and the development is not characteristic of the neighborhood. She stated this proposed

development is not a PUD and should be rezoned to R-20. She stated she is concerned with flooding, the fire rating and increasing school enrollment at the Lewisburg schools.

Supervisor Gardner stated it seems the neighbors would be agreeable with ¾ acre lots. Ms. Remington stated she would be happy with 3 acre lots and she is still concerned with the proposed sewer system.

Supervisor Medlin stated that a PUD usually sets aside 10% open space and Mr. Bailey is stating that the minimum house size will be 1800 sqf, where is this documented. Mr. Haysley stated he believes that it is documented in the project site plan.

Ms. Betty Dixon - 1140 Craft Road- came forward and stated that unless someone lives in the Lewisburg area they are not personally affected by this development. She stated the community does not want their schools overcrowded and they do not want an increase in traffic in the area.

Jason Wood - 1116 Aquilla- came forward and stated he lives in Villages of Hawks Crossing and in his subdivision even a 12,000 sqf lot has a minimum house size of 2300 sqf. He stated he does not see how rear loading garages with alley ways will work on the size lots proposed in this development. He stated he thinks it is uncharacteristic of the neighborhood.

Marcel Robicheaux -1108 Merloun Drive- came forward and stated there is already classes in the school that are at maximum capacity and there are many lots still not developed, why approve more.

Jack Massey - 4660 Sunset Drive- came forward and stated I-269 is going in front of his home and asked about the corridor study. He then stated we are going to have growth and does not have a problem with 20,000 sqf lots that not everyone can afford 10 acre lots.

Supervisor Medlin asked how wide the streets in the back of the lots are. Mr. Bailey stated they are 18 ft. wide.

Stephen Folks – 1151 Merloun Drive- came forward and stated he is concerned with future development and what the proposed subdivision will lead to. He stated he is also concerned with the minimum house size, future lots being smaller than the ones currently propose, traffic problems, school overcrowding and the proposed sewer system.

Supervisor Medlin stated the 80 acres behind the proposed property is currently approved for ¾ acre lots. Supervisor Gardner stated the property beside the proposed development says for future development and asked Mr. Bailey what would be his plans for that area. Mr. Bailey stated the market would dictate the plan for that area.

Supervisor Russell asked what the average house size is in Villages of Hawks Crossing. Mr. Folks stated the average size of homes in Villages of Hawks Crossing is 3,000 sqf but the minimum house size is 2,000 sqf. Mr. Garrod stated he believes the minimum hose size is 2,000 sqf but the builders are exceeding the minimum. Supervisor Gardner clarified that there will not be 1,200 sqf homes in the area.

Supervisor Gardner stated that the neighbors want 30,000 sqf lots in the proposed development and asked Mr. Bailey to explain why he wants 20,000 sqf lots in the development. Mr. Bailey stated the cost of development dictates the smaller lot sizes with the cost of asphalt and such. He then stated there are people who like to live on smaller lots. Supervisor Gardner stated it seems rear loading garages and alley ways would cost more. Mr. Bailey stated they are putting more money into this subdivision than they have others. Supervisor Medlin asked how wide the boulevards would be. Mr. Bailey stated they would be 18 ft. Mr. Haysley clarified that the boulevards would be 18 ft. wide on each side.

Supervisor Medlin asked if Mr. Bailey would be willing to increase the minimum square footage of the homes to larger than 1,800 sqf. Mr. Bailey stated he would like to keep them 1,800 sqf. Supervisor Russell asked how big of a home could be built on size lots that are in the proposed subdivision. Mr. Bailey stated at least 4,000 sqf lots could be built on the lots. Supervisor Medlin asked if Mr. Bailey would be willing to install a certain type of uniform mailbox throughout the subdivision. Mr. Bailey stated the mail would be delivered to the rear of the home. He stated he will have a "no rentals allowed" in the covenants.

Mr. Robicheaux stated he is concerned the homes in the surrounding area will not remain at their current value if this development is approved.

Ms. Remington discussed what types of homes are selling in the area.

Mr. Abner asked who would enforce the "no rentals allowed" rule. Supervisor Russell stated the Homeowners Association would enforce that rule.

Ms. Debra Cleary -4888 Bright Heights Rd. – came forward and stated there are already traffic issues in this area, why add more traffic to an already bad situation. She then stated there is not infrastructure there to support this development. She stated she is also concerned with flooding in this area.

Supervisor Russell asked why this development is being called a PUD. Mr. Garrod stated that the only way to have this type of density is to have a PUD because of the Comprehensive Plan. Supervisor Russell stated that the Comprehensive Plan is not the Ordinance. Mr. Garrod stated it is not the Ordinance but should be used as a guideline. He then explained what a PUD is. Supervisor Russell asked if the Planning Department considered this project a PUD. Mr. Garrod said the Planning Department does consider this project a PUD due to the boulevard, the rear loading access and the natural areas/open spaces. Supervisor Gardner asked if it is safe to say that PUD's are not cookie cutter developments. Mr. Garrod stated it is safe to say that because the amenities and such can be negotiated in a PUD project.

Supervisor Russell asked if due to the drainage and the 100 year flood zone if houses will have to be raised 2 ft. Mr. Garrod confirmed houses will have to be raised 2 ft. due to the flood zone. Supervisor Russell asked about the roads in the development. Mr. Swims stated they look at the plan for the drainage and how the water will get out of the development. Supervisor Russell asked how the water will drain out of this particular development. Mr. Swims stated the development will have to have adequate ditches. Supervisor Russell asked if there will be pipes under the ditches. Mr. Swims stated he hasn't seen the plan yet, but that the developer's engineer will have to submit the plans that show they have done due diligence and show how it is drained. Mr. Garrod explained the new Flood Ordinance as it pertains to the elevation of roads.

Supervisor Medlin asked how wide the streets are that run north and south to the alley streets. Mr. Bailey stated they are 18 ft. wide and are privately owned and maintained by the Homeowners Association. He then stated only the main road will be maintained by the County. Mr. Murray Hayslip asked if a private drive can serve more than 3 lots. Supervisor Medlin stated that an easement can only serve 3 lots, that these are private roads owned by the HOA. Supervisor Gardner asked if the HOA dues will be adequate to maintain the roads. Mr. Bailey confirmed that the dues would be adequate to maintain the roads.

Mr. Abner asked who enforces the "no on-street parking" rule. Supervisor Lee stated the HOA enforces that rule.

Ms. Alice Sturgehill -1591 Craft Road- asked what are the citizens of dark corner going to do when this development causes more flooding in their community. Supervisor Russell explained that the development cannot have any more runoff than is there predevelopment.

Supervisor Russell made a Motion to approve Crosswinds Rezoning (729) based upon a finding, after consideration of the comments of the applicants, the planning department staff, and the public and consideration of all the documents presented that there is substantial evidence to conclude there has been substantial changes in the character of the neighborhood and there is a public need for the zoning classification requested.
